# ALIXPARTNERS' 2019 LITIGATION AND CORPORATE COMPLIANCE SURVEY


Our annual survey of general counsel and compliance officers shows the rise of litigation matters on multiple fronts – and in-house litigation departments moving aggressively to respond.

#### AT A GLANCE

- 1 Data privacy and data security issues continue to be top-of-mind for in-house counsel, with 94% and 92% citing data security and information governance, respectively, as key issues over the last two years.
- In-house legal departments are bulking up. A surge in hiring and spending on internal resources, coupled with increased use of outside law firms suggests that the threat of a dispute is high.
  1 in 6 respondents have been involved in a bet-thecompany dispute.
- 3 Litigation is on the rise. Since our 2017 survey, our respondents have indicated increased involvement (read: more than double) in data privacy, financial reporting, and corruption.

**51%** of respondents say that matters are increasing, up from 25% in 2017.

#### **INTELLECTUAL PROPERTY**

Over the last two years, IP disputes have increased (31% of respondents in 2019 noted that their involvement in IP matters has increased, up from 15% in 2017). Patent litigation filings are continuing to decline, but trade secret litigation is on the rise, especially since passage of the Defend Trade Secrets Act in 2016.

#### INTERNATIONAL ARBITRATION IS ON THE RISE

In 2017, 45% of respondents said they had been involved in an international arbitration. This year, 67% of respondents said they had been involved.

In last year's survey, 20% of our respondents said their firms had been involved in more than 4 international arbitrations. In our latest survey, that number jumped to 40%. This suggests that companies involved in new arbitrations will see more.

#### **CROSS-BORDER CONCERNS**


The percentage of survey respondents who said they've been involved in a cross-border litigation in the past year jumped from 23% in 2017 to 38% in 2019.

Most commonly cited regions:

- North America (55%)
- United Kingdom (20%)
- China (17%)

North America and the UK are the top regions where companies face regulatory challenges involving cross-border data issues.




## **IN-HOUSE LITIGATION DEPARTMENTS**

### INCREASING INTERNAL RESOURCES...

The number of survey respondents saying their company's in-house litigation department had increased in size jumped from 26% in 2017 to 49% for 2019.

Meanwhile, the number saying their company has spent more on litigation rose from 39% to 50% in that same time frame.

### ....WHILE ALSO INCREASING EXTERNAL SPEND:

In 2017, 24% of our respondents said their company was making greater use of outside law firms. In 2019, that number rose to 33%.

Decisions, decisions, decisions: how do in-house counsel choose outside counsel? The most important areas under consideration:

### SUBJECT MATTER EXPERTISE

68% cited as extremely important

### RESPONSIVENESS

**57%** cited as extremely important

Other influencing factors cited as important:

- Service differentiation: 44%
- Prior relationship: 39%
- Personalities of team: 37%
- Rates/fees: 34%

### **IN-HOUSE LAWYERS ARE LOOKING TO REDUCE RISKS**

### Three strategies are on the rise:

Implementing technology as a tactic has increased more than 50% in the last two years (38% noted as increasing in 2017; 59% in 2019)

Monitoring and enforcing document retention policies (32% noted as increasing in 2017; 44% in 2019)

Leveraging data and analytics for compliance monitoring (27% noted as increasing in 2017; 40% in 2019)
